The event occurred on 07/21/2022 at approximately 20:40 at MANDARIN ORIENTAL HOTEL, 1330 MARYLAND AVENUE SW, WASHINGTON, DC 20024.

This statement of facts is based on my own recollection without having the legal authorization to review any associated body footage to assist in writing a statement as accordance to the Comprehensive Policing and Justice Reform Second Emergency Amendment Act of 2020 passed by DC Council.

On Thursday July 21, 2022 at approximately 1940 hours members of the First District responded to 1330 Maryland Avenue SW for a call for service reporting a male shot on the 8th floor of the Mandarin Oriental Hotel. Officers Kern, Davis, Hugee, Bauserman, Boone, Festo, Boyle, Petty, Hart, Carella, Sadat, Costner, and numerous other officers responded to the scene. Officers were advised the shooting occurred on the 8th floor in room 853. Management for the hotel advised they initially had a fire alarm go off on the 8th floor from that room and went to check on it, when they opened the door they observed blood on the wall.

When officers approached the door, loud verbal commands were given advising police were on scene and asking the occupants to open the door. At that time, Ms. Shanteari Weems, DOB 05/04/1972, hereinafter referred to as Defendant Weems, began talking with the officers through the door. Defendant Weems was asked to come out of the room so officers could assist the person shot, but Defendant Weems began making statements like "I'm going to shoot myself", "if you come in, I'm going to shoot myself", and when asked to verify if there was a person shot inside she said "fuck him, he's a child molester." Victim-1 did state he was inside and shot to the head and leg, to which Defendant Weems said "shut the fuck up, I will kill you."

Once it was confirmed that Victim-1 was inside with gunshot wounds, members on scene moved to make entry to the room so that treatment could be rendered to Victim-1. Entry was made to the room at 2011 hours and Defendant Weems was immediately detained. While detaining her, she stated the gun was in her purse that she was holding, and that there was another gun in the room but she didn't know where. The room was held pending an emergency search warrant to recover the weapons and any other items of evidentiary value.

While Defendant Weems was detained, she made other spontaneous utterances about her relationship with Victim-1. Defendant Weems stated she has been married to Victim-1 for five years and that they live in Baltimore, Maryland together. Defendant Weems owns a child daycare business and had recently been told by numerous children at her business that Victim-1 has been molesting them. Defendant Weems went to the Baltimore authorities to report this conduct. Defendant Weems then also said she didn't want to kill him, she just wanted to hurt him, but she does want to kill herself.

Defendant Weems was placed under arrest for Assault with Intent to Kill, was identified verbally and transported to the First District Station for processing.

The event and acts described above occurred primarily in the District of Columbia and were committed as described by defendant(s) listed in the case caption.
